Later he turned to the field of Environmental Conflict Management initiating and developed new research and teaching initiatives the university, including the popular Conflict Management Course (60-100 MSc students/yr) as well as the specialized Advanced Conflict Management Course. He carried out research in Europe, USA and Africa, and is currently involved in research and capacity building at the Wangari Maathai Institute for Peace and Environmental Studies at University of Nairobi. Jens Emborg takes an interdisciplinary and holistic approach to complex problems by integrating natural and social science in his work. He has worked in policy and management settings and throughout his career bridged between research, policy and practice.
